# Stockton-on-Tees Borough Council The County Alderman Worsley Justice of the Peace Scholarship Information for people applying

## Eligibility

We will consider you for a scholarship if you:

- are currently studying or about to study full- or part-time at either a university or any other institution of further or higher education; and
- live in the Thornaby area.

We may offer awards even if you receive any other bursary or grant. We will expect you to tell us about necessary spending not covered by other awards.

We must receive your application by 30 September in any year. We will consider all applications we receive by that date. If you have any questions about your claim, phone 01642 526604.

### 1 History of the trust

The trust was set up in 1947 under the will of John Stapleton Worsley, a county alderman of the former North Riding of Yorkshire County Council. The trust was originally set up to benefit students going to evening classes at the former Thornaby-on-Tees Evening Institute. Later, the institute closed and new schemes were identified until 1 June 1993, when the Education Committee set up the current scheme. The County of Cleveland, as trustees of the foundation, passed their powers under the foundation to the Education Committee. On that date the Education Committee approved new rules for running the trust. These are included in the following paragraphs.

### 2 Using the trust's income

The yearly income of the trust will be used to provide scholarships at any university, or other institution of further or higher (including professional and technical) education approved by the Education Committee. These scholarships will be awarded each year but may be renewed for later years, if the student makes satisfactory progress.

### 3 Beneficiaries

Students must live in Thornaby-on-Tees (unless they are in full-time education elsewhere) and need financial help to follow their course of study. We will consider people who go to university, college or evening classes.

### 4 Value of scholarships

The trustees will decide on the value of individual scholarships according to the number of qualified people who apply and the merits of each case. The scholarship will never reduce any bursary or other award you may receive.

### 5 Qualifications

You must have been accepted for a full-time or part-time course of vocational study at an institution we approve (see paragraph 2). You must also meet the conditions of paragraph 3.

### 6 Choosing students to benefit

Each year the Corporate Director of Children, Education & Social Care will publicise the Trust and send details to the head of each educational institution where there might be students who want to apply. They will also send details to Thornaby councillors, libraries and other council offices in Thornaby.

You can get an application form from the Pupil Support Section, Children, Education and Social Care, PO Box 228, Municipal Buildings, Church Road, Stockton-on-Tees, TS18 1XE.

In your application, you must give:

- full details of the course for which you need the scholarship;
- details of help you expect to receive from other sources and, if relevant, why this will not be enough;
- the subject of any evening classes you go to or have been to and where these were held;
- any other information which we may need; and
- your personal financial circumstances and, if you are still in full-time education, the financial circumstances of your parents or guardians.

### 7 If your financial circumstances change

If we award a scholarship, we will expect you to tell the Corporate Director of Children, Education and Social Care if your financial circumstances significantly improve after you apply. If you do not give this information, we may cancel the award and ask you to repay the scholarship.
