1 The trust

The Yarm Grammar School Trust was set up by the Charity Commissioners on 14 January 1983.

2 Trustees and benefits

The trustees will decide who receives benefits from the charity at meetings they hold at least twice a year (usually in January and July).

If you are applying for the January meeting, please send your application no later than 30 November. If you are applying for the July meeting, send your application by 31 May. If you have any questions about your claim, phone 01642 526604.

3 Income from the trust

The trust's financial year will be from 1 April to 31 March in each year. The trustees will use the yearly income in the way described in the following paragraph. The trustees will invest any income not needed for awarding benefits in the name of the 'Official Custodian for Charities'.

4 Beneficiaries and using the income

We will use the income from the charity, after paying management expenses, to promote education. This will include training people under the age of 25 who are, or who have a parent, living in the Parish of Yarm. This training will involve one or more of the following.

- Providing help to any school in the parish or serving the same benefits of any kind not normally provided by the local education authority, which may be agreed between the school governors and the trustees after consulting the local education authority.
- Providing financial help, outfits, clothing, tools, musical instruments or books so people who leave school, university or any other educational institution can prepare for, or enter, a profession or trade.
- Awarding bursaries or maintenance allowances so people can travel, whether in this country or abroad, to continue their education.
- Providing financial help so people can study music or other arts.
- Any other methods the trustees think are appropriate.
