

Annual Governance and Accountability Return 2020/21 Part 1

ONLY to be completed by PARISH COUNCILS AND OTHER SMALLER AUTHORITIES* (other than Parish Meetings) that are able to declare that they have had NO FINANCIAL TRANSACTIONS in the year of account 2020/21 and can certify themselves exempt from a limited assurance review.

Guidance notes on completing Part 1 of the Annual Governance and Accountability Return 2020/21

Smaller authorities that have had no financial transactions in the year of account 2020/21 **must**

1. Complete the attached **Declaration of No Accounts and Certificate of Exemption** following a meeting of the authority after 31 March 2021
2. Return a copy to the external auditor **either** by email **or** by post (not both) **no later than 30 June 2021**. The external auditor only notes that the authority has certified itself as exempt from a limited assurance review
3. Publish on the authority website/webpage a copy of the **Declaration of No Accounts and Certificate of Exemption BEFORE 1 July 2021**

Note: It is a legal requirement that you do so. Smaller authorities are required by the Accounts and Audit Regulations 2015 and the Transparency Code for Smaller Authorities to publish certain documents on the authority website/webpage.

Please note that the authority cannot complete this Part 1 Declaration of No Accounts and Certificate of Exemption if the authority:

- either received income or incurred expenditure in the year ending 31 March 2021; or
- was issued with a public interest report or received a statutory recommendation in relation to the year ending 31 March 2020; or
- was not in existence before 1 April 2017

In those circumstances, the authority **must** complete an Annual Governance and Accountability Return Part 2 or Part 3 as appropriate.

If the authority is a Parish Meeting it must complete an Annual Governance and Accountability Return Part 1PM, Part 2PM or Part 3PM as appropriate.

The Annual Governance and Accountability Return constitutes the annual return referred to in the Accounts and Audit Regulations 2015. Throughout, the words 'external auditor' have the same meaning as the words 'local auditor' in the Accounts and Audit Regulations 2015.


