**THE COUNCIL OF THE BOROUGH OF STOCKTON-ON-TEES  
CREATION OF PUBLIC FOOTPATH NUMBER 31A (STOCKTON)  
PUBLIC PATH CREATION ORDER 2021**

This Order is made by the Council of the Borough of Stockton-on-Tees "the Authority" under section 26 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that, having regard to the matters set out in section 26(1), there is a need for a public footpath over the land to which this order relates, and that it is expedient that the path should be created.

This order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Borough of Stockton-on-Tees definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(iii) of the 1981 Act, namely, a new right of way has been created (as authorised by this Order) hitherto shown or required to be shown in the map and statement

The Council of the Borough of Stockton-on-Tees have been consulted as required by section 26(3) of the 1980 Act and the Council of the Borough of Stockton-on-Tees have consented to the making of this order.

**BY THIS ORDER:**

1. There shall be after 28 days from the date of confirmation of this Order a public footpath over the land at Habron Woods, Norton described in Part 1 of the Schedule to this Order and shown by a bold red dashed line on the map attached to this Order and the Borough of Stockton-on-Tees definitive map and statement shall be modified as provided below.

**SCHEDULE**

**Part 1**

**Description of Land**

From point 'A', between 92 High Street and Sub Station and continue in an easterly direction for 151m through Habron Woods (Norton) between points B-C to re-join Public Footpath No.31 (Stockton) as indicated by a bold red dashed line on plan no. H117-277.

**Part 2**

**Modification of Definitive Statement of Public Right of Way**

The following wording shall be added to the definitive map following the creation of Public Footpath 31 (Stockton)

**Public Footpath No.31a (Stockton)** – Between 92 High Street and Sub Station, follow the tarmac surfaced footpath for approximately 81m between points A-B. Continue through Habron Woods following an un-surfaced 2m wide footpath in a

north easterly direction between points B-C to re-join Public Footpath No.31 (Stockton) for approximately 71m to the rear of 5 Crathorne Road.

Width: Varies between 1.2 metres – 2m wide between points A-B and 2m wide between points B-C

Surface: Tarmac/unsurfaced (in parts)

Renumber Parts as appropriate

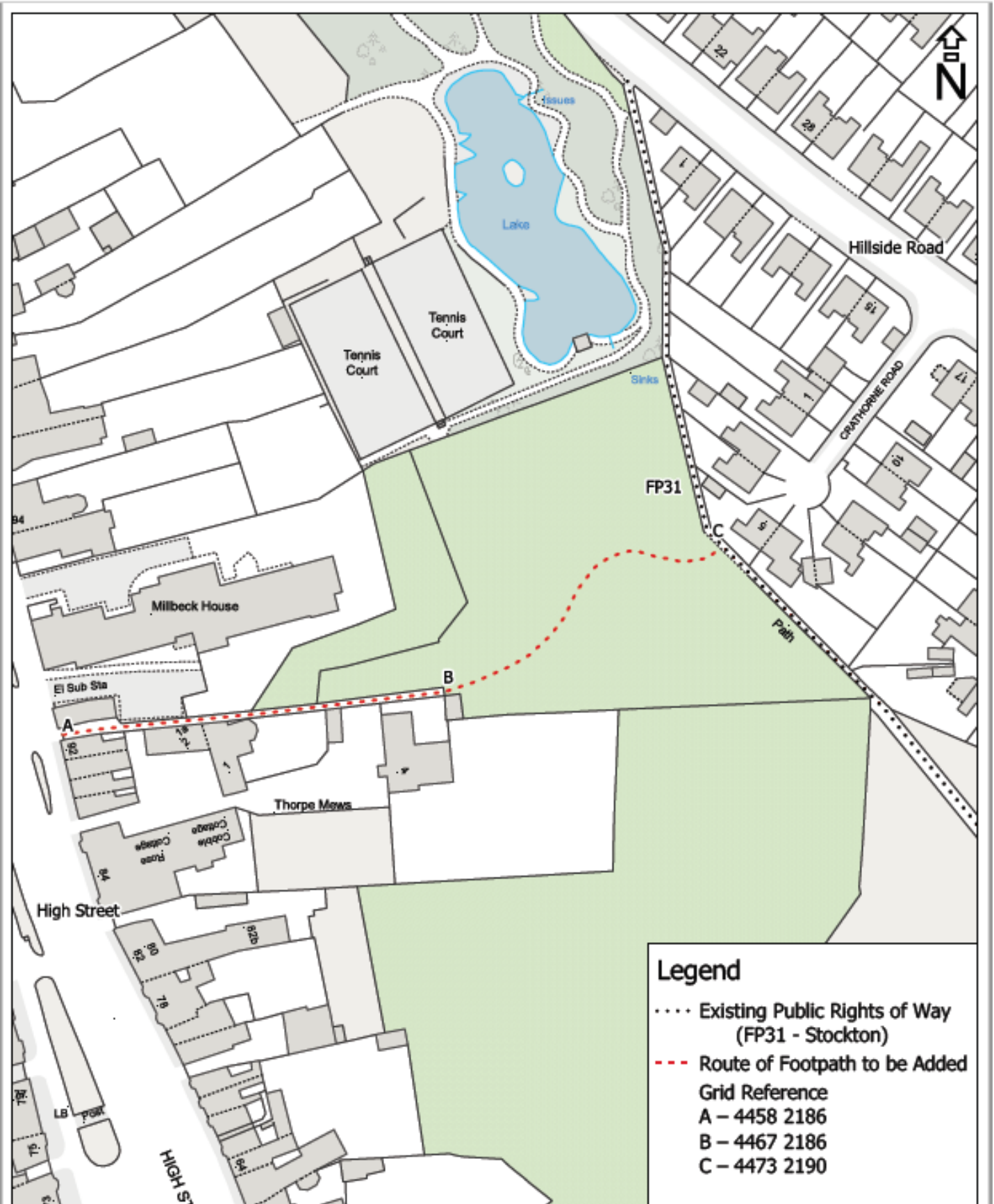
