ROAD TRAFFIC REGULATION ACT 1984

WHEREAS the Council of the Borough of Stockton-on-Tees (hereinafter referred to as "the Council") is satisfied that restrictions are necessary along the said section of road specified in the Schedule hereto because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to such works.

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and all other enabling powers hereby make the following Order:-

1. The Order shall come into operation on the 31<sup>st</sup> day of October 2021 and may be cited as The Stockton-on-Tees Borough Council, Preston Park Halloween Event, Temporary Clearway Order 2021.
2. No vehicle shall stop, wait, load or unload goods on the lengths of road specified in the Schedule to this order at any time when traffic signs have been erected notifying road users of the restriction except with the consent of a police officer in uniform or a Civic Enforcement Officer employed by Stockton on Tees Borough Council. Contravention of the temporary clearway would result in removal of the vehicle.

**SCHEDULE**

**Temporary Clearway – No Stopping  
Sunday 31<sup>st</sup> October 2021 (from 12:00hrs – 21:00hrs)**

Road	Description
A135 Yarm Road Eaglescliffe (both sides)	Between its junction with Witham Avenue and Preston Cemetery, a distance of approximately 1,275 metres.
Moorhouse Estate, Stockton on Tees (both sides)	From its junction with Yarm Road in a north-westerly direction for approximately 178 metres.  From a point approximately 282 metres northwest of its junction with Yarm Road for a distance of approximately 140 metres in a north-westerly direction.
Preston Lane, Stockton on Tees (both sides)	From its junction with Yarm Road in a south-easterly direction for a distance of approximately 250 metres.
Pennypot Lane, Eaglescliffe (both sides)	From its junction with Yarm Road in a westerly direction and northerly direction for a distance of approximately 115 metres.
Worsley Close, Eaglescliffe (both sides)	Full length.
Bardsley Close, Eaglescliffe (both sides)	Full length.
Cowley Close, Eaglescliffe (east side)	From a point approximately 68 metres east of its

	junction with Pennypot Lane for a distance of approximately 74 metres in a southerly direction.
Chestnut Road, Eaglescliffe (north side)	Full length.
Cedar Crescent, Eaglescliffe (north/west/east side)	Full length.
Myrtle Road, Eaglescliffe (west side)	From its junction with Chestnut Road to its junction with Oak Road
Oak Road, Eaglescliffe (north side)	From its junction with Myrtle Road in an easterly direction for a distance of approximately 95 metres.  From its junction with Sycamore Road in a westerly direction for a distance of approximately 37 metres.
Sycamore Road, Eaglescliffe (east side)	From its junction with Oak Road in a southerly direction for a distance of approximately 8 metres.  From a point approximately 44 metres south of its junction with Oak Road to its junction with Chestnut Road.
Lime Road, Eaglescliffe (south side)	Full length.
Larch Crescent, Eaglescliffe (south/west/east side)	Full length.
