SCHOOL TIME WAITING RESTRICTIIONS ORDER 2018 (AMENDMENT) ORDER 2021**

The Council of the Borough of Stockton-on-Tees ("the Council") in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. This Order shall come into operation on the 29th day of October 2021 and may be cited as The Borough of Stockton-on-Tees, Barley Fields and St Therese of Lisieux, Ingleby Barwick School Time Waiting Restrictions Order 2018 (Amendment) Order 2021.
2. The Borough of Stockton-on-Tees, Barley Fields and St Therese of Lisieux, Ingleby Barwick School Time Waiting Restrictions Order 2018 ("the 2018 Order") shall be amended as follows but shall otherwise remain in full force and effect.

(1) The words specified in Schedule 1 hereto are to be inserted into The Schedule of the 2018 Order.



SCHEDULE 1

Wording to be instered into The Schedule of the 2018 Order – ‘No waiting 8.00am to 9.30am and 2.30pm to 4.00pm’

Road	Length
Rothbury Close, Ingleby Barwick (east side)	From a point approximately 10 metres south of its junction with Blair Avenue in a southerly direction for an approximate distance of 100 metres (including the turning head).
Rothbury Close, Ingleby Barwick (west side)	From a point approximately 10 metres south of its junction with Blair Avenue in a southerly direction for an approximate distance of 55 metres.
Rothbury Close, Ingleby Barwick (west fork, east side)	From the driveway access of 34 Rothbury Close in a north/east direction for a distance of approximately 20 metres.
