Council Tax Reduction for Annexes

In accordance with The Council Tax (Reductions for Annexes) (England) Regulations 2013 annexes which are used by the occupier of the main house as part of the main home, or annexes which are occupied by a relative of the person living in the main house will be entitled to a 50% reduction in the Council Tax payable on the annexe.

To qualify for the reduction the following conditions must be met:

- a) The dwelling must form part of a single property which includes at least one other dwelling; and
- b) The dwelling must be used by a resident of that other dwelling or, as the case may be, one of those other dwellings, as part of their sole or main residence; or
- c) The dwelling is the sole or main residence of a relative of the person who is liable to pay council tax in respect of that other dwelling or, as the case may be, one of those other dwellings.
